The annual percentage change in the PPI for manufactured goods was 3.0% in December 2020 unchanged from 3.0% in November 2020. The monthly increase was 0.2% in December 2020 vs 0.0% in November 2020.

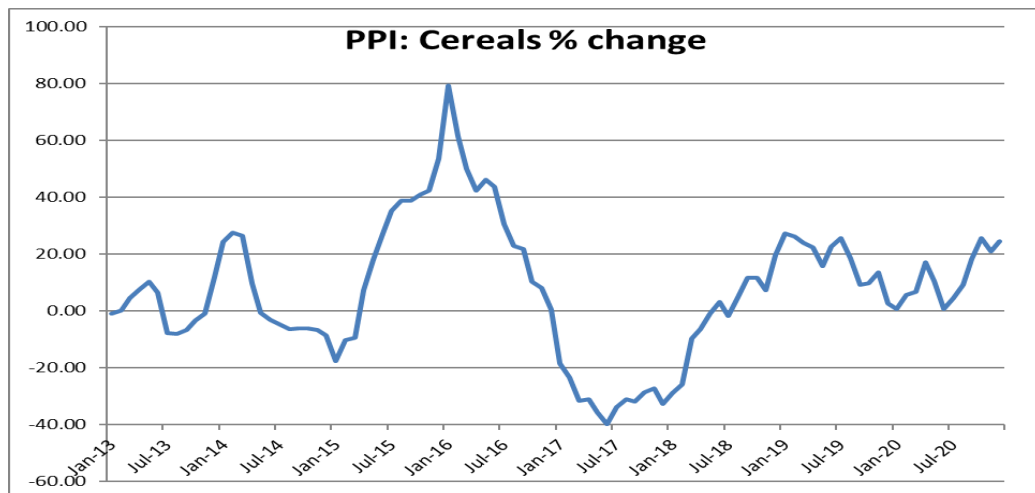
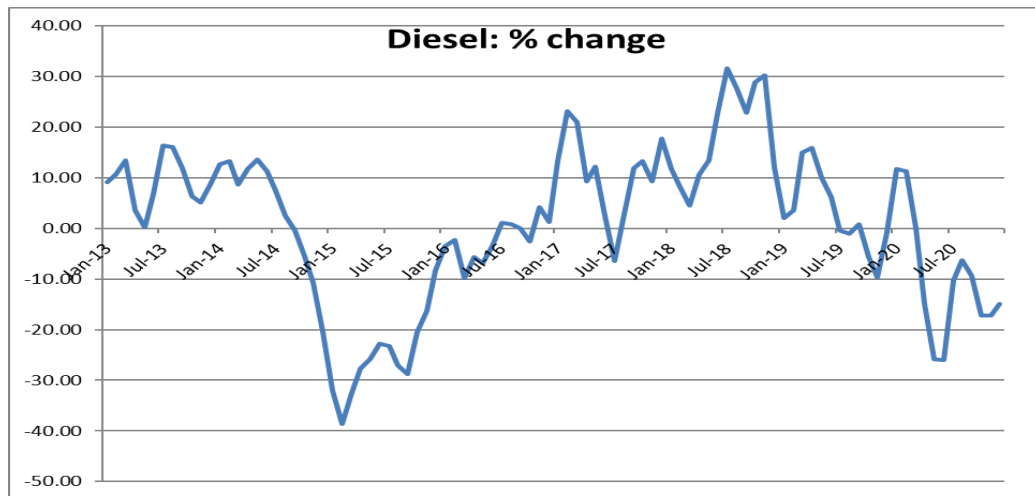
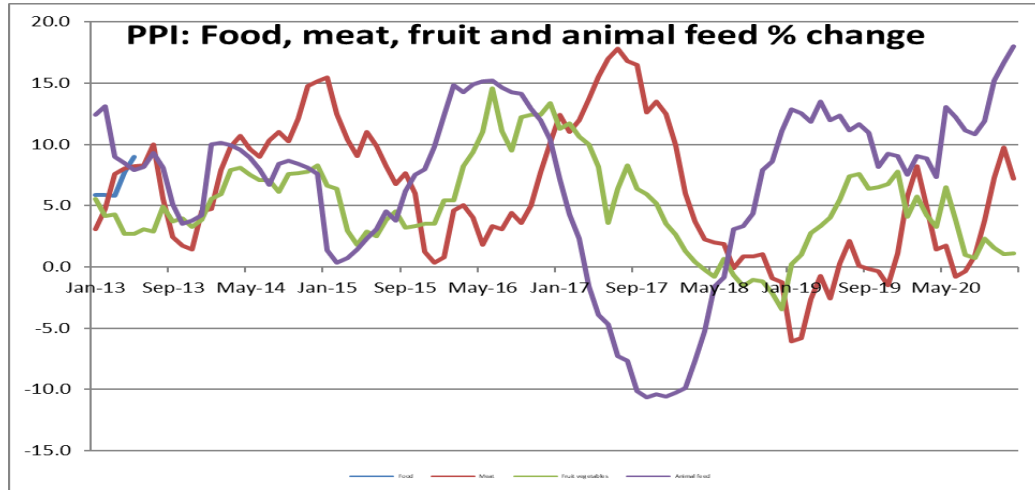
