



## **Privacy Statement**

CJS Securities is committed to protecting your privacy and developing technology that gives you the most powerful and safe online experience. This Statement of Privacy applies to the CJS Securities website and governs data collection and usage. By using the CJS Securities website, you consent to the data practices described in this statement.

### **Collection of your personal information**

CJS Securities collects personally identifiable information, such as your e-mail address, name, home or work address or telephone number. CJS Securities also collects anonymous demographic information, which is not unique to you, such as your ZIP code, age, gender, preferences, interests, and favourites.

There is also information about your computer hardware and software that is automatically collected by CJS Securities. This information can include: your IP address, browser type, domain names, access times and referring Web site addresses. This information is used by CJS Securities for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the CJS Securities website.

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through CJS Securities public message boards, this information may be collected and used by others. Note: CJS Securities does not read any of your private online communications.

CJS Securities is not responsible for the privacy statements or other content on Web sites outside of the CJS Securities and CJS Securities family of Web sites.

### **Use of your Personal Information.**

CJS Securities collects and uses your personal information to operate the CJS Securities website and deliver the services you have requested. CJS Securities also uses your personally identifiable information to inform you of other products or services available from CJS Securities and its affiliates. CJS Securities may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered.

CJS Securities does not sell, rent, or lease its customer lists to third parties. CJS Securities may, from time to time, contact you on behalf of external business partners about a offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is not transferred to the third party. In addition, CJS Securities may share data with trusted partners to help us perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to CJS Securities, and they are required to maintain the confidentiality of your information.

CJS Securities website does not use or disclose sensitive personal information, such as race, religion, or political affiliations, without your explicit consent.

CJS Securities website keeps track of the Web sites and pages our customers visit within CJS Securities, in order to determine what CJS Securities services are the most popular. This data is used to deliver customized content and advertising within CJS Securities to customers whose behaviour indicates that they are interested in a particular subject area.

CJS Securities website will disclose your personal information, without notice, only if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on CJS Securities or the site; (b) protect and defend the rights or property of CJS Securities ; and, (c) act under exigent circumstances to protect the personal safety of users CJS Securities , or the public.

### **Use of Cookies**

The CJS Securities website use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a Web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize CJS Securities website pages, or register with CJS Securities website or services, a cookie helps CJS Securities website to recall your specific information on subsequent visits. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on. When you return to the same CJS Securities website, the information you previously provided can be retrieved, so you can easily use the CJS Securities features that you customized.
